**F. Student Complaints/Matters of Non Compliance/Legal Action**

**1. Greenway University - Denver**

Deputy Director Roberts brought before the Board's attention a matter of suspected non-compliance with the statutory minimum standards and Board rules, concerning Greenway University – Denver, a school currently under suspension. No school representative was present. After due deliberation and discussion, and based upon a reasonable belief that Greenway University, Denver has failed to meet one or more of the criteria established pursuant to Article 59, Title 12, C.R.S. ("Act") and the Rules and Regulations concerning the Private Occupational Education Act ("Rules"), Ms. Bennison Noll motioned to direct the Division to issue a Notice of Noncompliance ("Notice") to Greenway University, Denver, and to provide until the end of the business day on August 8, 2011, a date found reasonable to the Board, to respond to the Notice. The motion was seconded and unanimously passed, with the Board indicating intent to review this particular matter with any School response at the August 23, 2011, Board Meeting.

There being no other business, Mr. Narvaez motioned to adjourn the Board meeting. The motion was seconded and duly passed. The Board of Private Occupational Schools Meeting of August 1, 2011 adjourned at 11:21 A.M.
