#### Approval of the July 22, 2008 Minutes:

The Board reviewed the Minutes of the July 22, 2008 Board meeting. Mr. Douglass motioned for approval of the minutes as read. The motion was seconded and passed.

Everest College - Colorado Springs taken off the Staff Report. There were no contingencies.

## New Business Action Items:

## A. Consideration of Approval of Provisional Certificate of Approval

#### 1. United States Truck Driving School, Inc. - Centennial

Program Specialist Belisle brought to the Board's attention for consideration, United States Truck Driving School, Inc., Centennial, a new school with one program: Interstate Heavy Duty Truck Driving Program 160 (IHD160) and one stand alone course: Refresher Course proposed, by United States Truck Driving School, Inc., Centennial. School representative Christian Holmsen was present. The school satisfied the Board's inquiry. Upon determining that the school is in compliance with the required bond amount of \$15,230; that the school submitted a bond in the amount of \$16,000; and that the school can be reasonably maintained in compliance with the minimum standards as prescribed by the Private Occupational Education Act of 1981, as amended, and in compliance with the Division's minimum requirements, Mr. Martin in a combined motion, moved that a Provisional Certificate of Approval be granted to United States Truck Driving School, Inc., 7009 South Jordan Road, Centennial, CO 80212 for the period beginning August 26, 2008 and ending June 30, 2010, and that the program and course before the Board be approved. The combined motion was seconded and unanimously passed.

#### 2. Arts and Education Hairdressing Academy - Broomfield

Program Specialist Esquibel brought to the Board's attention for consideration, Arts and Education Hairdressing Academy, Broomfield a new school with one program: Hairstylist Apprentice, and six stand alone courses: (1) Long Hairdressing; (2) Bridal Services; (3) Inside Out Personal Growth and Public Speaking Workshop; (4) Teacher Training; (5) Transitional Color; and (6) Transitional Cutting, proposed by Arts & Education Hairdressing Academy, Broomfield. School representative Mary Garrard was present. It was the will of the Board to make three separate motions, for Provisional school, the program and the stand alone courses. The school satisfied the Board's inquiry. Upon determining that the school is in compliance with the required bond amount of \$100,000; that the school submitted a bond in the amount of \$100,000; and that the school can be reasonably maintained in compliance with the minimum standards as prescribed by the Private Occupational Education Act of 1981, as amended, and in compliance with the Division's minimum requirements, Mr. Douglass, moved that a Provisional Certificate of Approval be granted to Arts and Education Hairdressing Academy, 150 Flatirons Crossing Drive, Broomfield, CO 80021 for the period beginning

August 26, 2008 and ending June 30, 2010. Mr. Douglass moved the one program Hairstylist Apprentice be approved and the motion was seconded and unanimously passed, and Mr. Douglass moved that the six stand-alone courses before the Board be approved, contingent upon the discussed corrections being made and the motion was seconded and unanimously passed.
