A. Consideration of Approval Programs / Stand Alone Courses

Program Specialist Belisle brought to the Board's attention for consideration of renewal for all seven locations for H&R Block Income Tax School - Denver Central, Colorado Springs, Colorado Complex, Denver East, Denver West, Denver North and Denver South. No school representative was present. The school at each location has satisfied the Board's inquiry. Upon determining that the Brighton location is in compliance with the required surety level in the amount of \$5,050; that the school submitted a bond in the amount of \$25,000; the Greeley location is in compliance with the required surety level in the amount of \$20,200; that the school submitted a bond in the amount of \$23,000; the Littleton location is in compliance with the required surety level in the amount of \$12,625; that the school submitted a bond in the amount of \$25,000 and the Longmont location is in compliance with the required surety level in the amount of \$31,450; that the school submitted a bond in the amount of \$57,000; that the schools can be reasonably maintained in compliance with the minimum standards as prescribed by the Private Occupational Education Act of 1981, as amended, and in compliance with the Division's minimum requirements, Ms. Rovig moved that the Standard Certificate of Approval be granted to all locations for Academy for Dental Assisting Career, 30 South 29th Avenue, Suite D, Brighton, CO 80601; Academy for Dental Assisting Careers, 3400 W.16 Street, Bldg., 8, Greeley, CO 80634; Academy for Dental Assisting Careers, 12999 W. Bowles Drive, Littleton, CO 80127; and Academy for Dental Assisting Careers, 1446 Hover Street, Longmont, CO 80501 for the period beginning July 1,

2014 and ending June 30, 2017. The combined motion was seconded and unanimously passed.

C. Consideration of Renewal of Certificate of Approval with Programs/Courses

1. Cloverleaf University, LLC - Denver

Program Specialist Oerman brought to the Board's attention for consideration of renewal Cloverleaf University, Denver and for review and consideration two new stand alone courses: (1) Responsible Cultivators Certificate; and (2) Responsible Manufacturers Certification. A school representative was present. After discussion and consideration, the school satisfied the Board's inquiry. Upon determining that the school is in compliance with the required surety level in the amount of \$8,970; that the school submitted a bond in the amount of \$10,000; and that the school can be reasonably maintained in compliance with the minimum standards as prescribed by the Private Occupational Education Act of 1981, as amended, and in compliance with the Division's minimum requirements, Mr. Wolf moved that the Standard Certificate of Approval be granted to Cloverleaf University, LLC, 601 W. 11th Avenue, Suite 508, Denver, CO 80204 for the period beginning July 1, 2014 and ending June 30, 2017, and the above-referenced courses be approved effective February 25, 2014. The combined motion was seconded and unanimously passed.

2. <u>Eastburn Institute of Hypnosis - Westminster</u>

Program Specialist Oerman brought to the Board's attention for consideration of renewal Eastburn Institute of Hypnosis, Westminster and for review and consideration one new stand alone course: Hypnotherapist Internship Certification. No school representative was present. Upon determining that the school is in compliance with the required surety level in the amount of \$20,000; that the school submitted a bond in the amount of \$20,000; and that the school can be reasonably maintained in compliance with the minimum standards as prescribed by the Private Occupational Education Act of 1981, as amended, and in compliance with the Division's minimum requirements, Ms. Rovig moved that the Standard Certificate of Approval be granted to Eastburn Institute of Hypnosis, 7905 N. Zenobia, Westminster, CO 80030 for the period beginning July 1, 2014 and ending June 30, 2017, and the above-referenced course be approved effective February 25, 2014. The combined motion was seconded and unanimously passed.

D. Consideration of Approval of Provisional Certificate of Approval

1. Ferrara Aesthetics - Durango

Program Specialist Oerman brought to the Board's attention for consideration, Ferrara Aesthetics, Durango, a new school with one proposed program and two stand alone courses. The program is: Esthetics Program. The stand alone courses are: (1) Microdermabrasion course and (2) Dermal Planning. School representatives were present. The school satisfied the Board's inquiry. Upon determining that the school is in compliance

with the required surety level in the amount of \$4,000; that the school submitted a bond in the amount of \$5,000; and that the school can be reasonably maintained in compliance with the minimum standards as prescribed by the Private Occupational Education Act of 1981, as amended, and in compliance with the Division's minimum requirements, Ms. Rovig in a combined motion moved that a Provisional Certificate of Approval be granted to Ferrara Aesthetics, 50 Sunshine Court, Durango, CO 81301 for the period beginning February 25, 2014, ending June 30, 2015, and that the program and courses before the Board be approved, contingent on corrections being made. The combined motion was seconded and unanimously passed.

2. She She University - Fort Collins

Program Specialist Belisle brought to the Board's attention for consideration, She She University, Fort Collins, a new school with four proposed programs, and five new standalone courses. The programs are: (1) Cosmetology; (2) Hairstylist; (3) Esthetician; and (4) Manicuring. The courses are: (1) Chemical Peels; (2) Waxing by a Manicurist; (3) Advanced Brazilian Waxing; (4) Advanced Nail Art; and (5) Microdermabrasion. School representatives were present. The school satisfied the Board's inquiry. Upon determining that the school is in compliance with the required surety level in the amount of \$13,500; that the school submitted a bond in the amount of \$20,000; and that the school can be reasonably maintained in compliance with the minimum standards as prescribed by the Private Occupational Education Act of 1981, as amended, and in compliance with the Division's minimum requirements, Mr. Semakula in a combined motion moved that a Provisional Certificate of Approval be granted to She She University, 115 E. Mountain Avenue, Ft. Collins, CO 80524 for the period beginning February 25, 2014, ending June 30, 2015, and that the programs and stand-alone courses before the Board be approved. The combined motion was seconded and unanimously passed.

F. Consideration of Approval of Out of State School

1. Financial Strategies. Inc - Carmel, IN

Program Supervisor Esquibel brought to the Board's attention for consideration an application for one out-of-state school Financial Strategies, Inc., Carmel, IN. The Board after determining that the out-of-state school meets the minimum requirements as set forth in 12-59-111(2), C.R.S.; that the school's bond be set in the amount of the statutory minimum of \$50,000; that the out-of-state school demonstrate compliance with the bond requirements pursuant to 12-59-115(8), C.R.S.; and that it can be reasonably maintained in compliance with the minimum standards as prescribed by the Private Occupational Education Act of 1981, as amended, and with the minimum requirements of the Division, Mr. Wolf motioned that the out-of-state school, Financial Strategies, Inc., 695 ProMed Lane, Carmel, IN 46032, be granted the Standard Certificate of Approval for the period beginning February 25, 2014 and ending June 30, 2014. The motion was seconded and unanimously passed.

Other Business:

Director Candler summarized two current bills before the legislature: House Bill 14-1136 concerning exempting from regulation by the Board/Division of Private Occupational School a nonprofit entity offering continuing professional education program or courses for the purposes or renewal or maintenance of a license that is approved by a state professional licensing board; and Senate Bill 14-149 concerning amending the minimum standards that a Private Occupation School must satisfy before being issued a Certificate of Approval to operate in Colorado.

As originally proposed, HB 14-1136 exempts a continuing professional education program from regulation non-profit entities offering programs or courses approved by the applicable Colorado professional licensing entity for maintenance or renewal of a professional license. Also, the program must be consistent with the purposes or requirements of the organization that provides the program.

SB14-149 specifically removes section 12-59-106(2), C.R.S., which permits the Board/Division to authorize USDOE approve accredited institutions based on their accreditation as a means of satisfying the majority of the minimum standards under section 12-59-106(1). The proposed bill removes the statutory provision that exempts the board from requiring accrediting schools to meet the same rigor as unaccredited schools requiring all schools (regardless of accreditation status) to compliance with each of the statutory standards. This change is necessary in order to comply with new Federal mandates under 34 CFR section 600.9 pertaining to state authorization requirements. Director Candler advised the Board that both bills are currently assigned to the respective committees for discussion and public testimony and will continue to provide updates on both legislative bills as they progress through the legislature.

Adjournment:

There being no other business, Ms. Rovig motioned to adjourn the Board meeting. The motion was seconded and duly passed. The Board of Private Occupational Schools' Meeting of February 25, 2014, adjourned at 11:32 A.M.
