Approval of the April 23, 2013 Board Meeting Public Session Minutes:

Approval of the April 23, 2013 Executive Session Minutes:

The Board reviewed the April 23, 2013 meeting minutes. Ms. Malay moved for approval of the minutes as read. The motion was seconded and passed.

Additions / Changes to the Agenda:

Director Lorna Candler requested the following changes/additions to the agenda: Under section "A" - Consideration of Approval Programs/Stand Alone Courses that item number "3" Aveda Institute Denver, be pulled from the agenda as it is a minor revision that does not require Board action. Director Candler also asked that under "Other Business" Boulder College of Massage Therapy - Boulder be added as item number "3". The Board concurred with the requested changes.

Staff / Director Report:

Director Candler introduced and welcomed two new board members: Richard Semakula of Heritage College; and as the financial representative, Joseph James Wolf of U.S. Bank.

Program Specialist Viteri reported that all contingency approvals concerning Board action taken at the April 23, 2013 meeting have been met, recorded, and are on file with the Division.

A. Consideration of Approval Programs / Stand Alone Courses

1. UCH – MHS School of Radiologic Technology – Colorado Springs

Program Specialist Esquibel brought to the Board's attention for review and consideration one new program, Magnetic Resonance Imaging, proposed by UCH – MHS School of

Radiologic Technology, Colorado Springs. A school representative was present. The school satisfied the Board's inquiry. Based upon the Board having determined that the above-referenced program for UCH – MHS School of Radiologic Technology, 175 S. Union Blvd., Suite 240, Colorado Springs, CO 80910, can be reasonably maintained in compliance with the minimum standards as prescribed by the Private Occupational Education Act of 1981, as amended, and with the Division's minimum requirements, Ms. Malay moved to approve the above-referenced program effective May 28, 2013. The motion was seconded and unanimously passed.

2. Heritage College - Denver

Board member Richard Semakula recused himself from the Heritage College, Denver matter only, citing an appearance of a conflict of interest, as the school's representative. A quorum and a two-thirds majority of the Board members were still present.

Program Specialist Esquibel brought to the Board's attention for review and consideration one program and four new stand-alone courses. The program is: (1) Diploma in Therapeutic Massage. The courses are: (1) Corrective Exercise Specialist; (2) Advanced Sports Conditioning; (3) Lifespan Fitness Solutions; and (4) Advance Fitness Nutrition, proposed by Heritage College. A school representative was present. Based upon the Board having determined that the above-referenced program and courses for Heritage College, 12 Lakeside Lane, Denver CO 80212 can be reasonably maintained in compliance with the minimum standards as prescribed by the Private Occupational Education Act of 1981, as amended, and with the Division's minimum requirements, Mr. Steele moved to approve the above-referenced program and courses effective May 28, 2013. The motion was seconded and unanimously passed.

3. Academy for Dental Assisting Careers - Longmont

Program Specialist Belisle brought to the Board's attention for review and consideration one new program, Fundamentals of Dental Technology, proposed by Academy for Dental Assisting Careers, Longmont. A school representative was present. The school satisfied the Board's inquiry. Based upon the Board having determined that the above-referenced program for by Academy for Dental Assisting Careers, 1446 Hover Street, Suite 250, Longmont, CO 80501, can be reasonably maintained in compliance with the minimum standards as prescribed by the Private Occupational Education Act of 1981, as amended, and with the Division's minimum requirements, Ms. Rovig moved to approve the above-referenced program effective May 28, 2013. It was the will of the Board to consider all in one action. The combined motion was seconded and unanimously passed.

F. Consideration of Change of Ownership

1. International Wine Guild - Denver

Program Specialist Belisle brought to the Board's attention for consideration application for a change of ownership for International Wine Guide. No school representative was available. Upon determining that the school is in compliance with the required minimum surety level in the amount of \$63,455; that the school submitted a bond in the amount of \$65,000; and that International Wine Guild, 1600 Wynkoop Street, Suite 300, Denver, CO 80202 can be reasonably maintained in compliance with the minimum standards as prescribed by the Private Occupational Education Act of 1981, as amended, and in compliance with the Division's minimum requirements, Mr. Steele moved that the change of ownership be granted for the period beginning May 28, 2013 and ending June 30, 2014. The motion was seconded and unanimously passed.

D. Notification of School Closings

As an informational item only the staff reported the closing of one school: National Beauty College, 2370 W Alameda Avenue, Unit 12, Denver, CO 80223. Staff confirmed that there were no enrolled students since the date of closure. Effective March 31, 2013 all available student and educational records have been transferred to the National Beauty College, 7045 Pecos Street, Unit A, Denver, CO 80221.

Other Business:

1. CollegeAmerica - Fort Collins

Board member Steven Steele recused himself from the CollegeAmerica matter only, citing an appearance of a conflict of interest. A quorum and a two-thirds majority of the Board members were still present.

Assistant Attorney General Erica Weston updated the Board on the status of the Stipulated Agreement and Final Agency Order reached concerning matters of non-compliance that arose from the two filed student complaints. A motion was made by Ms. Malay to ratify and otherwise accept the fully executed Stipulated Agreement and Final Agency Order, thereby effectively closing the two administrative complaints. The motion was seconded and passed unanimously.

2. Rulemaking

Director Candler updated the Board concerning the upcoming rulemaking process to affect those rules previously discussed at the November 2012 Annual Board Planning Meeting. In addition, the Director conveyed a need to consider two other rule changes: (1) Clarification and standardization of instructor qualifications; and (2) a change to current rules to reflect the state's use of clock hours rather than credit hours in all student curriculum/training computations and reporting in order to comport with stated U.S. Department of Education expectations for all accredited schools. Director Candler identified, however, a concern that the latter change will result in more discussion and stakeholder input before viable language

may be finalized for the Board's consideration. The Director suggested that the rule in regard to instructor qualifications be added to the Board's current rule agenda and filed as a "slate"; and that any rule concerning a credit to clock conversion be filed separately from the rest, on a different schedule. The Board concurred with the Director on all matters suggested.

3. Boulder College of Massage Therapy – Boulder

Director Candler reported that she would like to discuss with the Board, Boulder College of Massage Therapy's current status. The Board indicated it would like to consult with its legal counsel before proceeding, for the purpose of learning what legal options may be available to it under the circumstances reported, and in recognition that any discussion will likely include matters that are confidentially proprietary in nature for the School and School personnel. Ms. Malay motioned to convene into Executive Session pursuant to §24-6-402(3) (b) (III), C.R.S., on pending or imminent court action and pursuant to §24-6-402(3) (a) (II), to discuss matters required to be kept confidential. Mr. Steele seconded, and the motion to convene into Executive Session was unanimously passed.

The regular public board meeting recorder was turned off, and the Board of Private Occupational Schools convened into Executive Session at 10:46 A.M. for the purposes described above as requiring confidentiality. No member of the general public was present. The Executive Session recorder was turned on.

Executive Session concluded and the public session of the Board meeting reconvened at 11:31 A.M. The Executive Session recorder was turned off. The tape was removed and marked "May 28, 2013 Executive Session". The public session recorder was turned on and the general public was welcomed back.

Assistant Attorney General Weston affirmed for the public record that the Executive Session was for the sole purpose of providing legal advice to the Board and to otherwise engage in what in good faith is believed to be attorney-client privileged and/ or other matters required to be kept confidential.

As an informational item only, Director Candler provided a brief update concerning Boulder College of Massage Therapy, Boulder and the options this non-profit school is currently exploring given the schools financial instability and issues related to the real estate bond in particular. Director Candler advised that Board that an Interim Board Meeting maybe necessary to discuss the options of Boulder College of Massage Therapy.

Adjournment:

There being no other business, Ms. Rovig motioned to adjourn the Board meeting. The motion was seconded and duly passed. The Board of Private Occupational Schools' Meeting of May 28, 2013, adjourned at 11:33 A.M.
