## Sample Press Release

#### Colorado higher education institutions to waive application fees from Oct. 17-19

The sixth annual Colorado Free Application Day campaign returns as a three day-long event and encourages Colorado residents to continue their education beyond high school

**CITY/TOWN, CO**—To inspire more Coloradans to continue their education, all 32 public colleges and universities in Colorado and several private institutions will allow students to apply for free from Oct. 17-19 as part of Colorado Free Application Days.

Colorado Free Application Days caps off Colorado Applies Month, a statewide campaign that encourages high school juniors and seniors to explore, chart and execute a post-high school path. Once students select a goal—such as applying to an apprenticeship program—they are connected to resources and tools that will help them achieve major goals and action steps along the way. Admissions application information for each institution is available on the campaign website at <a href="https://cdhe.colorado.gov/cofreeappdays">https://cdhe.colorado.gov/cofreeappdays</a> and fees will be waived for applications submitted from Oct. 17-19 only.

The statewide push is designed to increase Colorado's college-going and FAFSA and CASFA completion rates. The campaign strategically aims to support low-income and first-generation students, while keeping Colorado students in state. According to 2021 numbers from CDHE's <a href="Pathways to Prosperity Report">Pathways to Prosperity Report</a>, 49.9% of high school graduates enrolled in postsecondary education the fall after graduation (a slight decrease from 2020) - race and ethnicity enrollment gaps persist.

"Our workforce demands that Coloradans are equipped with a postsecondary education and Colorado Free Application Days brings us one step closer to achieving that," said Gov. Jared Polis. "As we look ahead, our economy depends on a workforce that has the skills to fill the most indemand jobs and careers of tomorrow."

By waiving application fees—a common barrier to higher education—Colorado Free Application Days aims to improve access to further education and training, which is becoming increasingly critical in the state's rapidly-changing economy. The <a href="2022 Colorado Talent Pipeline Report">2022 Colorado Talent Pipeline Report</a> identified that 91.4% of Colorado's Tier 1 top jobs and 70.4% of Tier 2 top jobs require a credential beyond high school. However, only 61% of Coloradans 25- 64 years old hold a postsecondary credential, indicating a supply-and-demand gap for some occupations.

In response to these workforce demands, the Colorado Commission on Higher Education set a strategic goal to increase the number of Coloradans benefiting from valuable career skills, obtained while in high school or via postsecondary education, that —at a minimum— enable additional lifetime earnings greater than the cost of attendance, in its statewide plan for higher education, <a href="Building Skills for an Evolving Economy">Building Skills for an Evolving Economy</a>. Increasing postsecondary enrollment and reducing equity gaps—the racial disparities in educational attainment—are priority strategies to improve access and reduce costs for Coloradans.



## **Talking Points**

- All 32 public colleges and universities in Colorado and several private institutions will waive application fees as part of the sixth annual Colorado Free Application Days from Oct. 17-19, 2023.
- The fee waivers will be valid for applications submitted on Oct. 17-19 only. Students who want to take advantage of the fee waiver should be ready to submit a complete, high-quality application by October 19 to ensure they have the best chance for admission.

- National studies show that more than half of high-achieving students from low-income
  families end up at a college beneath their academic level, a phenomenon called
  undermatching. Troublingly, those who are undermatched are less likely to graduate on time
  and are more likely to stop out of their program. By waiving admissions application fees—a
  common barrier to higher education—we hope more Colorado students can find an
  education path that harnesses their talents and interests and graduate with a credential in
  hand.
- To help prepare applications, the Colorado Department of Higher Education has resources that walk students through the key steps in identifying education and training programs, preparing applications, and submitting them successfully.
- Colorado Free Application Days aims to support students of low-income backgrounds and first-generation students in their postsecondary journey. There are also options for students experiencing financial hardship to apply for free year-round.
- By keeping Colorado students in the state, our workforce and economy will strengthen and provide more career opportunities to students of color and individuals experiencing hardship.

## Frequently Asked Questions

### When is Colorado Free Application Days?

Colorado Free Application Days take place **from Oct. 17-19 only**. All public and some private institutions will waive application fees on those days.

#### How does it work?

You must submit a completed admissions application from **Oct. 17-19, 2023**. Any admissions applications that have been started but not submitted may not be granted a waiver.

Each institution will have a unique process to waive the admissions application submission fee. Visit the Colorado Free Application Days webpage to find specific information by institution.

To take advantage of Colorado Free Application Days, it's best to have all admissions application materials prepared, double-checked, and reviewed **before** Oct. 19. That way, you can submit high-quality, complete applications, and improve your chances of getting accepted.

#### Who should I contact if I have questions or technical difficulties?

If you encounter any technical problems when submitting your admissions application, please contact the Admissions Office of your school of choice. Their contact information will be listed on their website, which you can find on our <u>Colorado Free Application Days webpage</u>.

#### Why should I apply between Oct. 17-19?

Colorado's changing economy demands more education and training. Studies show that nearly three in four jobs in Colorado require a certificate or degree. To set yourself up for success, it's important to reach higher and find a path that suits your unique talents and interests.

Higher education is not just good for our state—it's good for you, too! Graduates of higher education programs are more likely to be employed, earn more money over their lifetime and lead healthier lives.

## What academic term should I apply for?

If you are applying to one of Colorado's community colleges and technical schools, you are welcome to apply for Spring or Fall 2024. If you're applying to a four-year college or university, you should apply for Fall 2024.

#### I'm a transfer student. Can I apply and receive the fee waiver?

Yes! Colorado Free Application Days are open to all Colorado residents.

## What if I'm not ready to submit my application by Oct. 19?

To take advantage of Colorado Free Application Days, it's best to have all admissions application



materials prepared, double-checked, and reviewed **before** Oct. 19. For the third year in a row, you have even more time, as we've extended Colorado Free Application from one day to three. That way, you can submit high-quality, complete admissions applications, and improve your chances of being accepted.

If you do not feel prepared to apply from Oct. 17-19, that's okay! You should wait until you have complete, high-quality admissions applications ready to submit. If you have trouble paying the admissions application fee, call or email the Admissions Office of your institution of choice; most institutions will waive admissions application fees in cases of financial hardship.

#### What if I apply prior to Oct. 17-19?

The waiver is valid for admissions applications submitted **between Oct. 17-19 only**. Any admissions applications submitted **before** Colorado Free Application Days **will not** be granted an automatic admissions application waiver.

If you want to apply before Colorado Free Application Days and have trouble paying the admissions application fee, call or email the Admissions Office of your institution of choice. Most institutions will waive admissions application fees in cases of financial hardship.

#### What if I miss the Oct. 17-19 window deadline?

The waiver is valid for admissions applications submitted from Oct. 17-19 only. Any admissions applications submitted **after** Oct. 19 **will not** be granted an automatic application waiver.

If you missed Colorado Free Application Days and have trouble paying the application fee, call or email the Admissions Office of your institution of choice. Most institutions will waive admissions application fees in cases of financial hardship.

#### How do I get my application ready?

The steps you need to take depend on for which program you intend to apply.

- If you are a high school graduate, you will likely be admitted to community colleges and technical schools automatically.
- If you have your sights set on a four-year college or university, you will likely need to submit additional materials and information, including your optional SAT or ACT scores, a personal essay and letters of recommendation.
