COEO/Director Candler provided a brief introduction for the purpose of today's emergency interim Board Meeting in order to extend the June 30<sup>th</sup>, 2020 expiration date for School Certificates expiring this renewal cycle.

## Other Business Items

1. Rule Change for an Extension of Renewal Deadline for School Certificates Expiring June 30th, 2020

COEO/Director Candler reported to the Board the necessity of extending the June 30<sup>th</sup>, 2020 renewal deadline for Schools renewing in 2020 due to COVID-19 restrictions. With the proposed rule change before the Board, the Division would be able to perform a thorough and timely review of all 2020 school renewal applications. Following discussion by the Board and Division, Board Member Krovitz made a motion to adopt the proposed emergency rule, finding that the immediate adoption of the rule is imperatively necessary to comply with state law and preserve the public welfare and that failing to adopt it would be contrary to the public interest. The motion was seconded and carried.

Additionally, COEO/Director Candler informed the Board that Governor Polis has indicated that the state is working on plans to allow further openings. Once the Department has further final information and guidance, it will be distributed to our Private Occupational Schools and stakeholders.
