1. Greetings and Introductions

- 2. Approval of November Meeting Notes [see handout: 2022-11-08- NOTES-AC.pdf] Notes approved
- 3. Announcements and Discussion Items
  - a. Updates from CCHE Advisor Landon Pirius
    - Dr. Pirius provided a thorough overview of the December 1 CCHE meeting, which was held remotely. He noted three items of interest an update on <u>HB22-1350</u> (Regional Talent Development Initiative Grant Program), an update on <u>HB22-1215</u> (Study of Expanding Extended High School Programs), and the approval of the CCHE Strategic Plan.
      - HB22-1350 is a \$90M grant opportunity being funded through the Colorado Office of Economic Development and International Trade (OEDIT) it is designed for organizations to partner together to address regional workforce needs. Three types of funding opportunities are available planning, seed, and scale. Letter of Intent process is now open, with a deadline in mid-January. Organizations can be a partner in as many applications as they want; however, they can only be a lead applicant once.
      - The HB22-1215 task force has issued an interim report
      - The Strategic Plan has been in development for several months passed with a unanimous vote. ROI heavy in the document. Council discussed limitations to, and continuing concerns about the ROI approach.
  - b. Updates on the Colorado Re-Engaged (CORE) Initiative—HB21-1330 (Peter Fritz, CDHE)
    - Peter Fritz, Director of Student Transitions and Degree Completion Initiatives, provided an update on the CORE initiative. He noted that draft contracts for the CORE Operational Grants have been sent to all participating IHEs once routed and signed, DHE will release grant funds. Peter also reported that he has received clarification from HLC regarding change of mission if an IHE is offering three or more associate degree types, then the IHE will be required to submit a change of mission form. Peter also discussed DHE's potential legislative update the



Department found a subset of students who would not be eligible for either Reverse Transfer (RT) or CORE. This legislative update could potentially affect ~6,300 students if adopted.

- c. Proposed revisions to CCHE Policy Section I, Part V: Creation, Modification or Discontinuance of Academic and Vocational Programs at Public Institutions of Higher Education (Chris Rasmussen, CDHE)
  - Dr. Rasmussen provided an overview of the proposed revisions to the policy to bring to the Commission at an upcoming meeting, potentially as soon as February. There was wide-ranging conversation about the proposed language addressing various particulars, including:
    - How will certificate completion be recognized in funding formulas
    - How to account for component courses that are produced by continued education units
    - How to recognize microcredentials as well as certificates (and what distinguishes the two)
    - How will certificate reporting be aligned with (or separate from) reporting for potential future federal gainful employment requirements
    - Does "eligible for entry into SURDS" mean that institutions will be required to report certificates to SURDS?
- d. Higher Learning Commission solicitation of feedback from members on proposed policy on faculty qualifications (with specific application to dual/concurrent enrollment)
  - Dr. Rasmussen noted that the Higher Learning Commission is soliciting feedback on potential revisions to HLC assumed practices related to faculty qualifications. This was shared with participants at a recent meeting in Chicago of HLC executive leadership and accreditation liaisons and state higher education personnel from the traditional 19 HLC states. Institutions were sent an <u>announcement</u> with the draft <u>policy</u> and a response prompt; submission are due by February 15 to <u>dualcredit@hlcommission.org</u>. There was robust discussing among council members and other meeting participants about the current policy and potential revisions.
