## IV. DISCUSSION/ACTION ITEMS

1. Student Unit Records Data System (SURDS) update
DHE staff informed Council members of a last-minute addition to the
agenda. Late last week, the Department's Data, Research, and Policy
(DRP) division informed the Academic Affairs team that access to SURDS



had been restored. Christina informed Council members that new and modified academic program information that had been entered into SURDS between February and June 2023 was not recovered - this information was re-entered on Friday and should be visible on the public website now. DRP has advised that no CIP code changes are to be made at this time; however new programs that have been reported to DHE since June 2023 can now be entered into SURDS. Christina informed Council members that she will begin entering new academic program information this week and estimates to have this completed by the end of the month.

2. General education credential framework name discussion (Allana Farley, CDHE)

Allana led a brief discussion with Council members regarding the potential names for consideration for the general education credential framework. The task force met last week and proposed "Colorado GenEd Foundational Skills Credential" based upon feedback received from both employers and students.

Task force members considered whether the term "GenEd" should be part of the name - it was noted that while the abbreviation "GenEd" was not preferred, it was widely understood and accessible by both students and employers. Task force members also considered whether "Colorado" should be included - many felt it was important to distinguish this framework was specific to Colorado, similarly to "Colorado Reverse Transfer" or "Colorado Re-Engaged Initiative." Council members affirmed the task force's recommendation of Colorado GenEd Foundational Skills Credential.

- 3. 2024 Legislative agenda updates
  Kim provided an update on the status of SB24-164 Institution of Higher
  Education Transparency Requirements the bill has had a number of
  amendments, some of which have been accepted. Institutions continue
  to express several concerns around language regarding learning
  outcomes and about the 30-day window for transcript evaluations.
  Institutions are concerned about the fiscal impact this unfunded
  mandate will have on them as they currently do not have the capacity to
  meet this requirement.
- 4. Discussion and affirmation of Otero College to the STAAs in Communication and Theatre (Christina Carrillo, CDHE)
  Christina informed Council members that no objections were received during the 30-day comment period regarding Otero College joining the STAAs in Communication and Theatre. Otero College has been approved and will be added to both agreements this week.
- 5. Discussion and affirmation of mathematics requirement update at the University of Colorado Colorado Springs (UCCS) on the STAA in Business



Christina informed Council members that no objections were received during the 30-day comment period regarding UCCS's new mathematics requirement on the STAA in Business. The STAA will be updated this week to reflect this change, effective fall 2024.

# 6. STAA updates (Christina Carrillo, CDHE)

# English

The faculty proposed and affirmed the following revisions to their agreement: changed the written communication requirement to be more flexible; reduced the number of arts & humanities credits from 9 to 6 - also changed this requirement to allow for one LIT course compared to none in the current agreement; updated the natural & physical sciences requirement to allow for a non-lab science course option; decided to move the oral communication requirement from "Additional Required Courses" to "Electives"; and a footnote was added to indicate that courses listed in the electives section are intended to be recommendations only and not requirements. These revisions result in 14 elective credit hours compared to the 8 in the current agreement. Council members approved the revisions and recommended moving forward for institutional approval.

## • Equine Science

The faculty proposed and affirmed the following revisions to their agreement: changed the written communication requirement to be more flexible; removed a footnote on a social & behavioral science course; removed a non-GT Pathways course as an option for students in the natural & physical sciences requirement; moved courses from the "Electives" course list to the "Required" course list; changes were made to the "Electives" list; and a footnote was added to indicate that courses listed in the electives section are intended to be *recommendations only* and not *requirements*. Council members approved the revisions and recommended moving forward for institutional approval.

## French

The faculty proposed and affirmed the following revisions to their agreement: changed the written communication requirement to be more flexible; and updated the footnote language regarding students who earn credit for FRE 1011 or FRE 1012 based on their proficiency level. Council members approved the revisions and recommended moving forward for institutional approval.

# Spanish

The faculty proposed and affirmed the following revisions to their agreement: changed the written communication requirement to be more flexible; updated the language regarding the HIS requirement to say "History of Latin America OR another GT



Pathways History course focusing on Spanish-speaking communities in or outside the U.S."; reduced the number of social & behavioral sciences credits from 6 to 3 to stay compliant with CCHE policy for GT Pathways yet felt strongly about students meeting content and competencies to add an additional 3 credits under "Additional Required Courses"; added COM 2300 Intercultural Communication (GT-SS3) as an option for oral communication; and updated footnote language for students who earn credit for courses based on their proficiency.

Council members expressed concern regarding the language of the History requirement. Council members were concerned about implementation from both the sending and receiving institutions - do institutions offer such courses? How are students and advisors to interpret the language that is currently being presented? Council members suggested changing the language to "any GT Pathways-approved HIS course, prefer HIS 2200 History of Latin America OR HIS 2210 History of Mexico." Christina will send the agreement back to faculty with the suggested revision and bring this agreement back in the fall.
