3. Announcements and Discussion Items
 - a. Updates from CCHE Advisor Michael Lightner
Dr. Lightner provided an overview of the April 5 CCHE work session and business meeting – the work session included a presentation from The Common Sense Institute on supply and demand; the business meeting included standing committee updates from Student Success & Workforce Alignment, Finance, Performance & Accountability, and HB22-1349 technical working group. Advisor Cavanaugh, who represents the independent and private institutions, has been keeping the Commission apprised of the FAFSA situation and shared completion rates are down nationally.
 - b. Update on the Colorado Re-Engaged Initiative (Peter Fritz, CDHE)
Dr. Rasmussen informed Council members that there are no significant CORE updates this month – he suggested removing this standing agenda item and returning to it as needed. Council members affirmed this suggestion.
 - c. 2024 Legislative agenda updates



Dr. Poast and Dr. Rasmussen provided an update on the status of [SB24-164 Institution of Higher Education Transparency Requirements](#) – the bill has had a number of amendments, some of which have been accepted. Institutions continue to express several concerns around language regarding learning outcomes and about the 30-day window for transcript evaluations. Institutions are concerned about the fiscal impact this unfunded mandate will have on them as they currently do not have the capacity to meet this requirement.

- d. Student Unit Record Data System (SURDS) update
DHE staff informed Council members that late last week, the Department’s Data, Research, and Policy (DRP) division informed the Academic Affairs team that access to SURDS had been restored. Christina informed Council members that new and modified academic program information that had been entered into SURDS between February and June 2023 was not recovered – this information was re-entered on Friday and should be visible on the public website now. DRP has advised that no CIP code changes are to be made at this time; however new programs that have been reported to DHE since June 2023 can now be entered into SURDS. Christina informed Council members that she will begin entering new academic program information this week and estimates to have this completed by the end of the month.
