- 3. Announcements and Discussion Items
 - a. Updates from CCHE Advisor Michael Lightner
 Dr. Lightner informed council members that he missed most of the CCHE meeting that occurred on February 7; however, he provided an overview of the portion that he did attend. He reported that Commissioners engaged in a discussion about the findings from the funding formula feedback survey, which was conducted in December and

January as part of the Commission's funding formula review process. He also reported that there were discussions about the recent Career Connected Learning Campus Designations, updates regarding the legislative session, and continued discussions on the minimum value threshold (MVT) calculations and the statewide longitudinal data system (SLDS).

Council members engaged in a brief discussion regarding the funding formula review process and the current legislative session. Department staff suggested inviting our legislative liaison to next month's meeting to provide a more comprehensive update to council members.

b. Proposed revisions to CCHE Policy I, Section L: Statewide Transfer and GT Pathways (Notification of Transfer Credit)

Carl provided an overview of the proposed revisions to the Statewide Transfer and GT Pathways policy that will go before the Commission for approval in March. He informed council members that the changes to policy reflect the modifications that were made to statute as a result of Senate Bill 24-164. The policy will now require institutions of higher education to provide students (both undergraduate and graduate) with a determination of transfer credit within 30 calendar days, upon meeting certain criteria. It was noted that with Commission approval of the policy, staff will be recommending that institutions have until July 1 to implement the new practices and to post their updated policies on their respective websites regarding the process.

Council members engaged in a brief discussion regarding the proposed changes to the policy and the recommended deadline for implementation. Council members suggested a September 1 deadline for implementation and Department staff agreed. Department staff will make this adjustment when presenting this item to the Commission in the coming weeks.
