#### B. Consideration of Renewal of Certificate of Approval

# 23. Rocky Mountain Laser College - Lakewood

Program Specialist Viteri brought to the Board's attention for consideration of renewal Rocky Mountain Laser College, Lakewood. A school representative was present. The school satisfied the Board's inquiry. Upon determining that the school is in compliance with the required surety level in the amount of \$42,000; that the school submitted a bond in the amount of \$54,000; and that the school can be reasonably maintained in compliance with the minimum standards as prescribed by the Private Occupational Education Act of 1981, as amended, and in compliance with the Division's minimum requirements, Mr. Semaluka moved that the Standard Certificate of Approval be granted to Rocky Mountain Laser College, 651 Garrison Street, 2<sup>nd</sup> Floor, Lakewood, CO 80215, for the period beginning July 1, 2014 and ending June 30, 2017. The motion was seconded and unanimously passed.

## 24. Medical Massage International - Denver

Program Specialist Viteri brought to the Board's attention for consideration of renewal Medical Massage International, Denver. A school representative was present. The school satisfied the Board's inquiry. Upon determining that the school is in compliance with the required surety level in the amount of \$1,200; that the school submitted a bond in the amount of \$5,000; and that the school can be reasonably maintained in compliance with the minimum standards as prescribed by the Private Occupational Education Act of 1981, as amended, and in compliance with the Division's minimum requirements, Mr. Steele moved that the Standard Certificate of Approval be granted to Medical Massage International, 2050 South Oneida Street, Denver, CO 80215, for the period beginning July 1, 2014 and ending June 30, 2017. The motion was seconded and unanimously passed.

#### 24. Medical Massage International - Denver

Program Specialist Viteri brought to the Board's attention for consideration of renewal Medical Massage International, Denver. A school representative was present. The school satisfied the

Board's inquiry. Upon determining that the school is in compliance with the required surety level in the amount of \$1,200; that the school submitted a bond in the amount of \$5,000; and that the school can be reasonably maintained in compliance with the minimum standards as prescribed by the Private Occupational Education Act of 1981, as amended, and in compliance with the Division's minimum requirements, Mr. Steele moved that the Standard Certificate of Approval be granted to Medical Massage International, 2050 South Oneida Street, Denver, CO 80215, for the period beginning July 1, 2014 and ending June 30, 2017. The motion was seconded and unanimously passed.

#### 25. Northern Colorado Truck Driving Academy – Fort Collins

Program Specialist Viteri brought to the Board's attention for consideration of renewal Northern Colorado Truck Driving Academy, Fort Collins. School representatives were present. The school satisfied the Board's inquiry. Upon determining that the school is in compliance with the required surety level in the amount of \$2,000; that the school submitted a bond in the amount of \$20,000; and that the school can be reasonably maintained in compliance with the minimum standards as prescribed by the Private Occupational Education Act of 1981, as amended, and in compliance with the Division's minimum requirements, Mr. Steele moved that the Standard Certificate of Approval be granted to Northern Colorado Truck Driving Academy, 425 John Deere Drive, Suite 3, Fort Collins, CO 80524, for the period beginning July 1, 2014 and ending June 30, 2017. The motion was seconded and unanimously passed.

# 26. Lotus Aesthetics International College - Lakewood

Director Candler brought to the Board's attention for consideration of renewal Lotus Aesthetics International College, Lakewood. A school representative was present. The school satisfied the Board's inquiry. Upon determining that the school is in compliance with the required surety level in the amount of \$1,500; that the school submitted a bond in the amount of \$5,000; and that the school can be reasonably maintained in compliance with the minimum standards as prescribed by the Private Occupational Education Act of 1981, as amended, and in compliance with the Division's minimum requirements, Mr. Wolf moved that the Standard Certificate of Approval be granted to Lotus Aesthetics International College, 820 Simms, Suite 11, Lakewood, CO 80401, for the period beginning July 1, 2014 and ending June 30, 2017. The motion was seconded and unanimously passed.

# C. Consideration of Renewal of Certificate of Approval with Programs/Courses

# 1. Denver Learning Institute - Denver

Program Specialist Esquibel brought to the Board's attention for consideration of renewal Denver Learning Institute, Denver and for review and consideration two new stand-alone courses: (1) Statistics for Business; and (2) Success Strategies for the Workplace. A school representative was present. After discussion and consideration, the school satisfied the Board's inquiry. Upon determining that the school is in compliance with the required surety level in the amount of \$12,958; that the school submitted a bond in the amount of \$150,000; and that the school can be reasonably maintained in compliance with the minimum standards as prescribed by the Private Occupational Education Act of 1981, as amended, and in compliance with the Division's minimum requirements, Mr. Semaluka moved that the Standard Certificate of

Approval be granted to Denver Learning Institute, 1515 Arapahoe Street, Tower 1, Suite 500, Denver, CO 80202 for the period beginning July 1, 2014 and ending June 30, 2017, and the above-referenced courses be approved effective April 22, 2014. The combined motion was seconded and unanimously passed.

# 2. <u>DanielleLee Beauty Academy – Fort Morgan</u>

Program Specialist Esquibel brought to the Board's attention for consideration of renewal Danielle Beauty academy, Fort Morgan and for review and consideration one new program: Hairstylist. School representatives were present. After discussion and consideration, the school satisfied the Board's inquiry. Upon determining that the school is in compliance with the required surety level in the amount of \$0; that the school submitted a savings account in the amount of \$5,000; and that the school can be reasonably maintained in compliance with the minimum standards as prescribed by the Private Occupational Education Act of 1981, as amended, and in compliance with the Division's minimum requirements, Ms. Malay moved that the Standard Certificate of Approval be granted to DanielleLee Beauty Academy, 113 ½ Main Street, Fort Morgan, CO 80701 for the period beginning July 1, 2014 and ending June 30, 2017, and the above-referenced program be approved effective April 22, 2014. The combined motion was seconded and unanimously passed.

# C. Consideration of Approval of Provisional Certificate of Approval

# 1. Salud Institute for Health Center Careers – Ft. Lupton

Program Specialist Oerman brought to the Board's attention for consideration, Salud Institute for Health Center Careers, Ft. Lupton, a new school with one proposed program, and one new stand-alone course. The program is: Medical Assisting. The course is: Medical Professional. A school representative was present. The school satisfied the Board's inquiry. Upon determining that the school is in compliance with the required surety level in the amount of \$9,000; that the school submitted a bond in the amount of \$10,000; and that the school can be reasonably maintained in compliance with the minimum standards as prescribed by the Private Occupational Education Act of 1981, as amended, and in compliance with the Division's minimum requirements, Ms. Malay in a combined motion moved that a Provisional Certificate of Approval be granted to Salud Institute for Health Center Careers, 203 S. Rollie Avenue, Ft. Lupton, CO 80621 for the period beginning April 22, 2014, ending June 30, 2015, and that the program and stand-alone course before the Board be approved. The combined motion was seconded and unanimously passed.

# 2. Westline Academy of Barbering - Colorado Springs

Program Specialist Oerman brought to the Board's attention for consideration Westline Academy of Barbering, Colorado Springs, a new school with two proposed programs: (1) Barber Program; and (2) Barber Apprentice Program. A school representative was present. The school satisfied the Board's inquiry. Upon determining that the school is in compliance with the required surety level in the amount of \$4,500; that the school submitted a bond in the amount of \$6,000; and that the school can be reasonably maintained in compliance with the minimum standards as prescribed by the Private Occupational Education Act of 1981, as amended, and in compliance with the Division's minimum requirements, Mr. Steele in a combined motion moved

that a Provisional Certificate of Approval be granted to Westline Academy of Barbering, 313 North Tejon Street, Suite #1, Colorado Springs, CO 80903 for the period beginning April 22, 2014, ending June 30, 2015, and that the programs before the Board be approved, contingent on corrections being made. The combined motion was seconded and unanimously passed.

## 3. Semion Academy - Denver

Program Specialist Esquibel brought to the Board's attention for consideration, Semion Academy, Denver, a new school with four proposed program, and three new stand-alone courses. The programs are: (1) Barber; (2) Hairstylist; (3) Esthetician; and (4) Cosmetology. The courses are: (1) Advance Men Cutting Technique Part 1; (2) Advanced Men Cutting Technique Part III. School representatives were present. The school satisfied the Board's inquiry. Upon determining that the school is in compliance with the required surety level in the amount of \$5,000; that the school submitted a certificate of deposit in the amount of \$5,000; and that the school can be reasonably maintained in compliance with the minimum standards as prescribed by the Private Occupational Education Act of 1981, as amended, and in compliance with the Division's minimum requirements, Ms. Malay in a combined motion moved that a Provisional Certificate of Approval be granted to Semion Academy, 507 Lincoln Street, Suite 102, Denver, CO 80203 for the period beginning April 22, 2014, ending June 30, 2015, and that the programs and standalone courses before the Board be approved. The combined motion was seconded and unanimously passed.

# 4. Tech Lectures - Denver

Program Specialist Viteri brought to the Board's attention for consideration, Tech Lectures, Denver, a new school that had requested approval at the previous Board meeting on March 25, 2014. Based upon the Division's recommendation to allow further investigation, the Board motioned to table this matter at the April meeting for further consideration after the Division gathered all information necessary for the Board's consideration.

At the April 22, 2014 meeting, the Board indicated it would like to consult with its legal counsel for the purpose of learning what legal options may be available to it and how approval may affect pending litigation. Mr. Steele motioned to convene into Executive Session pursuant to §24-6-402(3) (a) (II), C.R.S., on receiving legal advice on specific legal questions or imminent court action. Mr. Wolf seconded, and the motion to convene into Executive Session was unanimously passed.

The regular public board meeting recorder was turned off, and the Board of Private Occupational Schools convened into Executive Session at 10:45 A.M. for the purposes described above as requiring confidentiality. One member of the general public was present. The Executive Session recorder was turned on.

Executive session concluded and the public session of the Board meeting reconvened at 11:00 A.M. The Executive Session recorder was turned off. The tape was removed and marked "April 22, 2014 Executive Session". The public session recorder was turned on and the general public was welcomed back.

Senior Assistant Attorney General Dineen affirmed for the public record that the Executive Session was for the sole purpose of providing legal advice to the Board and to otherwise engage in what in good faith is believed to be attorney-client privileged matters required to be kept confidential.

Mr. Medina, appearing on behalf of his school, was given the opportunity to address the board members. He provided an explanation for the matters of non-compliance the Board had identified as its primary concerns. Upon one Board members observation that Mr. Medina seemed to be justifying his actions resulting in non-compliance with the Pharmacy Board and the matters of concern identified by the Board/Division, Mr. Medina further apologized for any wrong doing on his behalf.

The Board discussed the additional terms and conditional it would require of Mr. Medina through a written Stipulation and Order of the Board as essential in order to obtain Board approval. Therefore, upon determining that the school is in compliance with the required surety level in the amount of \$2,880; that the school submitted a bond in the amount of \$5,000; and that the school can be reasonably maintained in compliance with the minimum standards as prescribed by the Private Occupational Education Act of 1981, as amended, and in compliance with the Division's minimum requirements, Mr. Steele moved to allow a Provisional Certificate of Approval be granted to Tech Lectures, 5775 W. Dartmouth Avenue, 8-308, Denver, CO 80227, the period beginning April 22, 2014, ending May 27, 2014, for a period of thirty days pending a signed Stipulation Agreement in which Mr. Medina formally agrees to abide by all terms identified by the Board, including quarterly monitory, compliance with Pharmacy Board Order, prohibit communication with competitors. The Director will review advertising and marketing material and on-site inspections. Any violation during this probationary period will result in immediate revocation. The programs and stand-alone courses were tabled until the board meeting of May 27, 2014. The combined motion was seconded and unanimously passed.

#### **Adjournment:**

There being no other business, Ms. Rovig motioned to adjourn the Board meeting. The motion was seconded and duly passed. The Board of Private Occupational Schools' Meeting of April 22, 2014, adjourned at 11:26 A.M.
