**Approval of the March 24, 2015 Board Meeting Public Session Minutes:**

The Board reviewed the March 24, 2015, meeting minutes. Mr. Wolf moved for approval of the minutes as read. The motion was seconded and passed.

**Approval of the March 12, 2015 Interim Board Meeting Minutes:**

The Board reviewed the March 12, 2015, Interim meeting minutes. Ms. Malay moved for approval of the minutes as read. The motion was seconded and passed.

**Director’s Report/ Staff Report:**

Inta Morris, Chief Advocacy & Outreach Officer of the Colorado Department of Higher Education presented Director Candler’s report as follows. First, she provided an update on related legislative matters. She explained that the Sunset Bill passed as originally submitted and presented to the Senate and House committees whereby the Private Occupational School Act of 1981 will be continued until 2024. Secondly, the Yoga Exemption Bill also passed which means that yoga teacher training programs will no longer be regulated under the Act. Chief Morris also explained that the Division had received calls from Yoga Schools who offered teacher training programs approved and overseen by the Division; they explained that they still want to be regulated by DPOS.

On April 16, 2015, three of our Board Members were confirmed; congratulations to Mr. Joseph Wolf, Ms. Shelley Krovitz and Ms. Jean Robinson. As the Board members had received a written correspondence from Director Candler, Ms. Morris officially announced that Ms. Ledy Garcia-

Eckstein no longer meets the criteria; therefore the Division is seeking to fill the current vacancy for a "public member" to serve on the Board. The primary requirement for this "public member" is that individual is a business owner or operator in Colorado (but not a school owner or operator) who also has the capacity to hire a student who has been enrolled in one of the private occupational schools we regulate. For example, a business owner who could employ an industry person in para-medical (techs), manufacturing, dentistry, IT, or any of the other various trades and occupations we oversee. The basic time commitment involves preparation for & attendance at a regularly scheduled Board meeting every month; consideration issues, information and legal matters presented through the Division when necessary; and attendance at the annual Board retreat. The appointment is for three years. Please call the Division if you have a referral that meet these qualifications and would be interested in serving.

Lastly, the Division has received new dates for the Quinn Hearing (Massage School of Colorado); our hearing will be on June 24 & 25, 2015. In the separate matters issued through the Federal Law Suit, the AG's office will be filing a Motion to Dismiss the case.

Director Candler updated the Board on the CollegeAmerica matters. First, it currently has two Colorado Springs Campuses but recently announced that they are planning on closing one. Therefore, the upcoming renewals for CollegeAmerica will only concern the main Colorado Springs Campus and the Denver Campus. Given the continuation of outstanding issues that could potentially & significantly impact CollegeAmerica, the Division Director further suggested that the Board table review and consideration of the CollegeAmerica renewal matters until the following has been completed: 1) the Division has finalized the bond matters at issue; 2) The Attorney General's Preliminary Injunction hearing against CollegeAmerica has been resolved or reached decision in the District Court; and 3) the Department of Education reviews and determines that CollegeAmerica has met all requirements imposed including securing the appropriate Letter of Credit required to continue participating in HEA, Title IV federal student aid programs.

Director Candler gave the Board a brief update on BL International Beauty College, Denver by summarizing the issues raised in the Notice of Noncompliance as well as additional concerns the Division is currently monitoring. Since the Notice was issued, the School has paid their outstanding and current assessments fees. On April 13, 2015, we received their cursory response to the Notice of Noncompliance. Program Specialist Googins has visited the school with a representative from OBC and continues to work with BL. On an additional visit, the Director and Deputy Director joined Specialist Googins to further investigate and monitor the issues of concern. All were impressed by the progress the school had made. Director Candler stated that they would continue to closely monitor the school and would give the Board a full report on the BL International Beauty College at the next meeting. Ms. Malay motioned to table this matter and the motion was seconded and passed.

During the next meeting, Director Candler will also provide the Board with an update of the new information gathered though the NASASPS conference.

## **A. Consideration of Approval Programs / Stand Alone Courses**

### **1. Northern Colorado College of Real Estate - Loveland**

Program Specialist Oerman brought to the Board's attention for review consideration one new program, Community Association Manager, proposed by Northern Colorado College of Real Estate, Loveland. A school representative was present. The school is in compliance with adequate bond coverage in the amount of \$30,000 until June 2016. Based upon the Board's consideration and determination that the above-referenced program for Northern Colorado College of Real Estate, 3780 North Garfield Ave, # 104, Loveland, CO 80538 can be reasonably maintained in compliance with the minimum standards as prescribed by the Private Occupational Education Act of 1981, as amended, and with the Division's minimum requirements, Mr. Semakula moved to approve the above-referenced program effective April 28, 2015. The motion was seconded and unanimously passed.

## **2. LeaderQuest - Centennial**

Program Specialist Oerman brought to the Board's attention for review consideration three new stand alone courses: (1) CPTe – Certified Penetration Testing Engineer; (2) CDEF – Certified Digital Forensics Examiner; and (3) CVA – Certified Vulnerability Assessor, proposed by LeaderQuest, Centennial. School representatives were present. The school is in compliance with adequate bond coverage in the amount of \$160,000.00 until July 2015. Based upon the Board's consideration and determination that the above-referenced courses for LeaderQuest, 6825 S. Galena Street, Suite 100, Centennial, CO 80112 can be reasonably maintained in compliance with the minimum standards as prescribed by the Private Occupational Education Act of 1981, as amended, and with the Division's minimum requirements, Ms. Malay moved to approve the above-referenced courses effective April 28, 2015. The motion was seconded and unanimously passed.

## **3. LeaderQuest – Colorado Springs**

Program Specialist Oerman brought to the Board's attention for review consideration four new stand alone courses: (1) CPTe – Certified Penetration Testing Engineer; (2) CDEF – Certified Digital Forensics Examiner; (3) CVA – Certified Vulnerability Assessor; and (4) ITIL (IT Infrastructure Library) V3 Foundation, proposed by LeaderQuest, Colorado Springs. School representatives were present. The school is in compliance with adequate bond coverage in the amount of \$160,000.00 until July 2015. Based upon the Board's consideration and determination that the above-referenced courses for LeaderQuest 7222 Commerce Center Drive, Suite 235, Colorado Springs, CO 80919 can be reasonably maintained in compliance with the minimum standards as prescribed by the Private Occupational Education Act of 1981, as amended, and with the Division's minimum requirements, Mr. Wolf moved to approve the above-referenced courses effective April 28, 2015. The motion was seconded and unanimously passed.

## **B. Consideration of Renewal of Certificate of Approval**

### **1. Auguste Escoffier School of Culinary Arts - Boulder**

Program Specialist Hill brought to the Board's attention for consideration of renewal Auguste Escoffier School of Culinary Arts, Boulder. School representatives were present. The school satisfied the Board's inquiry. Upon determining that the school is in compliance with the required surety level in the amount of \$1,038,965.00; that the school submitted a bond in the amount of \$1,040,042.85; and that the school can be reasonably maintained in compliance with the minimum standards as prescribed by the Private Occupational Education Act of 1981, as

amended, and in compliance with the Division's minimum requirements, Ms. Robinson moved that the Standard Certificate of Approval be granted to Auguste Escoffier School of Culinary Arts, 691 S. Broadway, Suite B, Boulder, CO 80305, for the period beginning July 1, 2015 and ending June 30, 2018. The motion was seconded and unanimously passed.

## **2. ITT Technical Institute - Aurora**

Program Specialist Hill brought to the Board's attention for consideration of renewal ITT Technical Institute, Aurora. School representatives were present. The school satisfied the Board's inquiry. Upon determining that the school is in compliance with the required surety level in the amount of \$694,188.03; that the school submitted a bond in the amount of \$695,000.00; and that the school can be reasonably maintained in compliance with the minimum standards as prescribed by the Private Occupational Education Act of 1981, as amended, and in compliance with the Division's minimum requirements, Mr. Semakula moved that the Standard Certificate of Approval be granted to ITT Technical Institute, 14001 E. Iliff Avenue, Suite 118, Aurora, CO 80014, for the period beginning July 1, 2015 and ending June 30, 2018. The motion was seconded and unanimously passed.

## **3. ITT Technical Institute - Westminster**

Program Specialist Hill brought to the Board's attention for consideration of renewal ITT Technical Institute, Westminster. School representatives were present. The school satisfied the Board's inquiry. Upon determining that the school is in compliance with the required surety level in the amount of \$503,483.95; that the school submitted a bond in the amount of \$503,500; and that the school can be reasonably maintained in compliance with the minimum standards as prescribed by the Private Occupational Education Act of 1981, as amended, and in compliance with the Division's minimum requirements, Ms. Robinson moved that the Standard Certificate of Approval be granted to ITT Technical Institute, 8620 Wolff Court, Suite 100, Westminster, CO 80031, for the period beginning July 1, 2015 and ending June 30, 2018. The motion was seconded and unanimously passed.

## **4. 6<sup>th</sup> Street Hair Salon and Day Spa, Inc. - Durango**

Program Specialist Oerman brought to the Board's attention for consideration of renewal, 6<sup>th</sup> Street Hair Salon and Day Spa, Inc., Durango. A school representative was not present. The school satisfied the Board's inquiry. Upon determining that the school is in compliance with the required surety level in the amount of \$32,000; that the school submitted a bond in the amount of \$33,400; and that the school can be reasonably maintained in compliance with the minimum standards as prescribed by the Private Occupational Education Act of 1981, as amended, and in compliance with the Division's minimum requirements, Ms. Robinson moved that the Standard Certificate of Approval be granted to 6<sup>th</sup> Street Hair Salon and Day Spa, Inc., Durango, CO 81301, for the period beginning July 1, 2015 and ending June 30, 2018. The motion was seconded and unanimously passed.

## **5. Greater Pueblo Dental Assisting School – Pueblo**

Program Specialist Oerman brought to the Board's attention for consideration of renewal Greater Pueblo Dental Assisting School, Pueblo. A school representative was present. The school satisfied the Board's inquiry. Upon determining that the school is in compliance with the required surety level in the amount of \$8,500; that the school submitted a bond in the amount

of \$10,000; and that the school can be reasonably maintained in compliance with the minimum standards as prescribed by the Private Occupational Education Act of 1981, as amended, and in compliance with the Division's minimum requirements, Ms. Malay moved that the Standard Certificate of Approval be granted to Greater Pueblo Dental Assisting School, 1407 W. 29<sup>th</sup> Street, Pueblo, CO 81008, for the period beginning July 1, 2015 and ending June 30, 2018. The motion was seconded and unanimously passed.

#### **6. Colorado School of Dental Assisting - Broomfield**

Program Specialist Oerman brought to the Board's attention for consideration of renewal Colorado School of Dental Assisting, Broomfield. A school representative was present. The school satisfied the Board's inquiry. Upon determining that the school is in compliance with the required surety level in the amount of \$14,400; that the school submitted a bond in the amount of \$42,000; (umbrella bond with Grand Junction campus) and that the school can be reasonably maintained in compliance with the minimum standards as prescribed by the Private Occupational Education Act of 1981, as amended, and in compliance with the Division's minimum requirements, Ms. Malay moved that the Standard Certificate of Approval be granted to Colorado School of Dental Assisting, 300 Nickle Street, Suite 11, Broomfield, CO 80020, for the period beginning July 1, 2015 and ending June 30, 2018. The motion was seconded and unanimously passed.

#### **7. Colorado School of Dental Assisting – Grand Junction**

Program Specialist Oerman brought to the Board's attention for consideration of renewal Colorado School of Dental Assisting, Grand Junction. A school representative was present. The school satisfied the Board's inquiry. Upon determining that the school is in compliance with the required surety level in the amount of \$14,400; that the school submitted a bond in the amount of \$42,000; (umbrella bond with Broomfield campus) and that the school can be reasonably maintained in compliance with the minimum standards as prescribed by the Private Occupational Education Act of 1981, as amended, and in compliance with the Division's minimum requirements, Ms. Malay moved that the Standard Certificate of Approval be granted to Colorado School of Dental Assisting, 2532 Patterson Road, Unit 1, Grand Junction, CO 81505, for the period beginning July 1, 2015 and ending June 30, 2018. The motion was seconded and unanimously passed.

#### **8. IntelliTec College – Grand Junction**

Program Specialist Oerman brought to the Board's attention for consideration of renewal IntelliTec College, Grand Junction. School representatives were present. The school satisfied the Board's inquiry. Upon determining that the school is in compliance with the required surety level in the amount of \$145,870; that the school submitted a bond in the amount of \$790,000;(umbrella coverage for 3 campuses) and that the school can be reasonably maintained in compliance with the minimum standards as prescribed by the Private Occupational Education Act of 1981, as amended, and in compliance with the Division's minimum requirements, Mr. Semakula moved that the Standard Certificate of Approval be granted to IntelliTec College, 772 Horizon Drive, Grand Junction, CO 81506, for the period beginning July 1, 2015 and ending June 30, 2018. The motion was seconded and unanimously passed.

#### **9. IntelliTec College – Pueblo**

Program Specialist Oerman brought to the Board's attention for consideration of renewal IntelliTec College, Pueblo. School representatives were present. The school satisfied the Board's inquiry. Upon determining that the school is in compliance with the required surety level in the amount of \$139,834; that the school submitted a bond in the amount of \$790,000;(umbrella coverage for 3 campuses) and that the school can be reasonably maintained in compliance with the minimum standards as prescribed by the Private Occupational Education Act of 1981, as amended, and in compliance with the Division's minimum requirements, Mr. Wolf moved that the Standard Certificate of Approval be granted to IntelliTec College, 3673 Parker Blvd., Pueblo, CO 81008, for the period beginning July 1, 2015 and ending June 30, 2018. The motion was seconded and unanimously passed.

**10. Starkey International Institute of Household Management - Denver**

Program Specialist Oerman brought to the Board's attention for consideration of renewal Starkey International Institute of Household Management, Denver. A school representative was present. The school satisfied the Board's inquiry. Upon determining that the school is in compliance with the required surety level in the amount of \$53,653; that the school submitted a bond in the amount of \$60,000; and that the school can be reasonably maintained in compliance with the minimum standards as prescribed by the Private Occupational Education Act of 1981, as amended, and in compliance with the Division's minimum requirements, Ms. Malay moved that the Standard Certificate of Approval be granted to Starkey International Institute of Household Management, 1350 Logan Street, Denver, CO 80203, for the period beginning July 1, 2015 and ending June 30, 2018. The motion was seconded and unanimously passed.

**11. Max International Beauty School - Aurora**

Program Specialist Oerman brought to the Board's attention for consideration of renewal Max International Beauty School, Aurora. A school representative was present. The school satisfied the Board's inquiry. Upon determining that the school is in compliance with the required surety level in the amount of \$660.00; that the school submitted a bond in the amount of \$6,300; and that the school can be reasonably maintained in compliance with the minimum standards as prescribed by the Private Occupational Education Act of 1981, as amended, and in compliance with the Division's minimum requirements, Ms. Malay moved that the Standard Certificate of Approval be granted to Max International Beauty School, 2720 S. **13. National Personal Training Institute – Lakewood**

The school satisfied the Board’s inquiry. Upon determining that the school is in compliance with the required surety level in the amount of \$141,286.25; that the school submitted a bond in the amount of \$200,062; and that the school can be reasonably maintained in compliance with the minimum standards as prescribed by the Private Occupational Education Act of 1981, as amended, and in compliance with the Division’s minimum requirements, Ms. Robinson moved that the Standard Certificate of Approval be granted to National Personal Training Institute, 1658 Cole Blvd., Suite 50, Lakewood, CO 80401, for the period beginning July 1, 2015 and ending June 30, 2018. The motion was seconded and unanimously passed.

**14. Pima Medical Institute – Colorado Springs**

The school satisfied the Board’s inquiry. Upon determining that the school is in compliance with the required surety level in the amount of \$554,393; that the school submitted a bond in the amount of \$1,615,552; (umbrella coverage for 3 campuses Denver and Aurora) and that the school can be reasonably maintained in compliance with the minimum standards as prescribed by the Private Occupational Education Act of 1981, as amended, and in compliance with the Division’s minimum requirements, Ms. Malay moved that the Standard Certificate of Approval be granted to Pima Medical Institute, 3770 Citadel Drive North, Colorado Springs, CO 80909, for the period beginning July 1, 2015 and ending June 30, 2018. The motion was seconded and unanimously passed.

**15. Rita B Institute - Aspen**

Program Specialist Oerman brought to the Board’s attention for consideration of renewal Rita B Institute, Aspen. A school representative was available by telephone. The school satisfied the Board’s inquiry. Upon determining that the school is in compliance with the required surety level in the amount of \$0; that the school submitted a bond in the amount of \$25,000; and that the school can be reasonably maintained in compliance with the minimum standards as prescribed by the Private Occupational Education Act of 1981, as amended, and in compliance with the Division’s minimum requirements, Ms. Robinson moved that the Standard Certificate of Approval be granted to Rita B Institute, 112 S.
